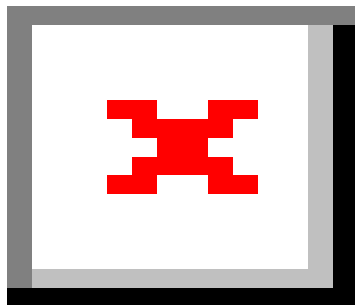

This was an unannounced inspection by regulating officer Steven White, Sue Beech accompanied me around the site for part of the inspection

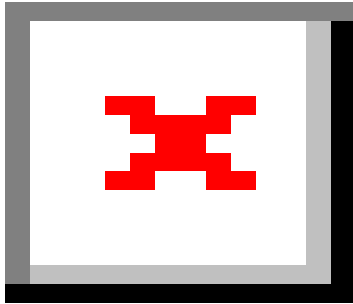
Site drainage - site concreted and drains to interceptor, to be emptied and upgraded the following week. Waste transfer notes for this need to be kept
