This is a routine site inspection. At the time of the visit site operator was present on site and an accompanied site inspection was carried out. All hazardous ELVs were stored appropriately on impermeable surface with sealed drainage. There were some treated ELVs on site available for inspection. Treated ELVs were shells only with no oil contaminated/containing parts present. All oil contaminated parts are stored inside a building. In general site is clean and tidy. General concerns within the ELV sector due to the low price of scrap metal.
