This was a routine, unannounced site inspection. It was carried out by the new regulating officer for the site, Steven White, who was accompanied by Environment Officer Paul Challender, officers met with site manager Sue Beach. A summary of the site visit and discussions is outlined below:

The site was tidy and well organised at the time of the inspection. The entire site is on concrete which flows to an interceptor close to the site entrance gate, vehicles are stacked two-high (unless they are large or awaiting depollution)

There were two depolluted cars that were being stored on the interceptor, you must ensure that the interceptor is kept clear of vehicles, checked and maintained regularly and emptied when required. This must be recorded in the site diary.

Once depolluted the cars are sent (2 at-a-time) to Delyn Metals for recycling, during the visit a recent delivery of cars to Delyn Metals was discussed where the regulating officer for the site believed that the vehicles had not been fully depolluted in that the shocks had not been drained. On discussions with the site and depollution manager it appears that they were drained but the cut to the shock was done to the rear where it is difficult to see. You must ensure that all vehicles that go to other permitted sites for recycling are fully depolluted prior to them leaving your site.
