Site visited by Jeremy Goddard (Natural Resources Wales) who met with Mr. Mark Tucker (permit holder).

General Site Inspection:

At the time of the visit the site was pre-operational and was yet to receive any waste material. Mr Tucker stated that he would like to start receiving waste as soon as possible.

It was clarified to Mr. Tucker that all waste received under the conditions of this permit must be deposited within the designated area for the purposes of recovery. There can be no preparatory treatment of waste and waste cannot be removed once received unless it is an unsuitable waste type which has been inadvertently delivered to the site.

A drainage pipe and settlement lagoons had been constructed along the north perimeter of the permitted site. Once waste starts to be accepted at the site the effectiveness of the drainage system in removing suspended solids from any surface water discharge should be constantly monitored with improvements made if necessary. Assessment should also be made as to whether a similar drainage arrangement would be required on the east perimeter of the permitted site.

It was suggested to Mr. Tucker that as much area as possible between the tipping area and any watercourse should be kept vegetated. This will help act as a 'buffer zone' for any suspended solids running off the tipping area in times of heavy rain and reduce the likelihood of them reaching a watercourse. This is especially important on the steep flanks of the permitted area. It was also suggested that to minimise the area of bare waste material at any one time the restoration should be split into different zones with each one competed and seeded before the next is begun.

Technical Competence:

Mr Tucker has provided Natural Resources Wales with his Operator Competence Certificate. The qualification - 'Treatment of land for reclamation, restoration or improvement of land (4MTRR6)' appears sufficient for this type of permit.
