The purpose of the inspection was to assess the compliance of Mark Tucker with Environmental Permit EPR/CB3297TB.

General Site Inspection

The purpose of the permit is to allow the deposit of waste to restore an area of land to agricultural use.

At the time of the inspection there was very little activity taking place on site. All waste present had been deposited within the designated areas for the purposes of recovery. Most of the material brought to site comes from Carmarthenshire County Council. The site was well organised and tidy and there appeared to be no rogue waste present.

Environment Management System

It was noted that the copy of the Environment Management System held on file by Natural Resources Wales was dated December 2013. As this is a live, working document it is recommended that updates be made every 2 - 4 years in order to ensure that it reflects the current operations and management on site.

Action - Please review the Environment Management System and notify Natural Resources Wales of any changes made.

WAMITAB

The current WAMITAB qualification for the site expired in July 2016.

Condition 1.1.4 of your environmental permit states;

"The operator shall comply with the requirements of an approved competence scheme"

To meet the requirements of WAMITAB, Technically Competent Managers must take the Continuing Competence Test every 2 years. This is to ensure that their knowledge and skills have kept pace with changes made across the Waste Management Industry, such as the

introduction of new legislation, technologies and/or techniques.

Action - Please ensure that a Continuing Competency course is booked and completed as soon as possible and provide Natural Resources Wales with evidence of this.
