A routine site visit took place on the 15th August, 2017. The visit took place in the company of Mr Sean Benyon.

The site is still Operational with green waste arriving into the reception building during the inspection. Vessel number 1 was being emptied with the material transferred to the maturation pad.

Lagoon leachate, consisting mainly of rainwater, was carried off site by John Hughes of Ty Mawr. The leachate was then spread to land by John Hughes under a deployment authorised by NRW.

PAS 100 compost was being taken off site by Thomas of Pentraeth.

Site Environmental Management System to be updated as this still contains the emergency contact details of the previous site manager.

Bio-aerosol monitoring report for June 2017 was received by NRW on 17th July, 2017. The report was checked against the reporting requirements of the permit and found to be compliant.

The Local Authority were exploring the possibility of closing the IVC at Penhesgyn. A tender process has begun for expressions of interest for the composting of green waste on behalf of the local authority. The TCM will keep NRW informed if there are any changes to operations on site.

No permit breaches recorded during this visit.
