B2 - Infrastructure - Closure & Decommissioning

The purpose of the visit was to discuss surrendering of permit Reference EAWML 37121 and assess decommission progress on site. Present in the meeting was Mark Goddard and Rob Chick of Tradebe

A low risk surrender application has been submitted to Natural Resources Wales by the operator.

It was noted today that the specific area where waste activity has been carried out under permit reference EAWML 37121 has now had been cleared, levelled out and reseeded.

In previous Compliance Assessment Report Ref 37121/0203772 Natural Resources Wales requested that Tradebe should determine as to whether or not a small area of grass was stained by a hazardous material. Your site condition report confirms that this was found to be from a lubricant that was used on the peristaltic pumps that were in use on the site and that the lubricant was 'not classified as a hazard or environmental hazard'. However, as part of the decommissioning process, the patch of stained land was removed and back-filled with clean soil.

There was a pile of what appeared to be filter bed material stored nearby. However Environment Officer was informed that this is material stored by Welsh Water / Dwr Cymru who occupy the overall site.

Above ground tanks and associated pipe work have been removed off site. The site did however mention that some of the underground pipes have been left in situ.

Examples of Duty of care paperwork was submitted by the operator for the disposal of the rainwater stored within the tanks.
