Discussed the closure of the site. The plan is still to have left the site by the beginning of November. No plans to surrender the permit at present although it was discussed. Operator is aware he will have to continue paying the subsistence fees until the permit is either surrendered or transferred to a new operator.

In the process of removing all stock from the site.

Still accepting one or two ELVs per week to depollute.

During the walk around site a couple of ELVs were observed that still contained a relatively small amount of washer fluid but no other issues.

No date for when the baler will be on site to remove all remaining ELVs was known at the time of the inspection. Please contact us with dates once known.

Quite a few small bits were observed on the ground during the inspection. When the site closes you must ensure that as much waste as possible has been removed from the site, including all small bits.
