

1 The Development:

Bayliss Recovery Ltd are proposing the construction of a metals recovery facility on plot G2, Princes Way, Bridgend Industrial Estate, Bridgend. This facility will be used for the recycling of ferrous and non ferrous metals. Metals will be purchased, processed and then removed from site. Motor vehicles will be accepted but will not be processed at the site. Metals will be processed using an 800 tonne mobile Taurus baler/shears which will be used for the compacting and shearing of ferrous metals. A 360° handler machine will be used to move materials around the compound and a 15,000mm weighbridge will be installed at the site to weight vehicles entering and exiting the compound.

A portal building will be constructed on the western side of the site and this shall be used as office/welfare facilities and for the storage of non ferrous metals. The entire surface of the site will be covered in an impermeable surface. Surface runoff shall be channelled to a sealed drainage system which shall discharge via a Class I Hydrocarbon Interceptor.

Gregory Environmental Ltd have been commissioned to carry out a preliminary contaminated land assessment of the site and to advise on the requirement for ongoing assessment.

3 The Site:

The site is located on plot G2, Princes Way, which sits at the junction of Princes Way and North Road on the Bridgend Industrial Estate and covers an area of approximately 3,800m². This is the site of the former Bridgend Royal Ordnance factory, which was a Second World War munitions filling factory where bombs, shells, cartridges, etc were filled with propellant and explosive compounds. Following decommissioning of the ROF the site's use continued to be industrial, up until approximately 1990 when all of the buildings on the site were demolished. The site has been vacant since then. The eastern end of the site, around the Princes Way/North Road junction has been landscaped with the remainder of the site being rough grassland and scrub interspersed with areas of concrete and gravel. There are several mature sycamore trees around the periphery of the site.

4 The Investigation:

The investigation has been carried out in two phases, the first being a desk study which has involved the review of historic maps of the site, geological, hydro-geological, waste management, abstraction and borehole data and British Geological Survey maps. A review of data on abstractions, IPPC consents, active and former landfills and premises with Waste Management Licenses. We have undertaken an archive search for historic and current information pertaining to the site.

The second phase was a site visit where the topography of the site was considered and sensual indicators of contamination looked for. These included odours, discolouration, sheens on water, voids and softspots across the sites surface, etc. During the site visit shallow trial pits were excavated by hand in order to gain a picture of the soil type likely to be encountered and to identify any shallow contamination.

4.1 Desk Study:

An information package was gained from Envirocheck, which included Geological Coverage Maps, Environment Agency and Hydrological data, waste management data, hazardous substances data, industrial land use data, sensitive land use data, groundwater vulnerability data, flood risk data, British Geological Survey Borehole data, historic maps and aerial photos.

4.1.1 Historic Mapping:

Historic mapping reviewed dates from 1885 to 2008.

1885 – Scale 1:10,560 – The area on which the site currently sits is farmland with the site straddling two field boundaries. The Great Western Railway is evident to the north of the site and there is a well to the SE of the site at 292200 178600.

1875 – 1878 – Scale 1:2,500 – Site is shown as farmland, as above. An ‘old quarry’ is shown to the east of the site. This will have been filled during the construction of the ROF but is unlikely to have any impact on the site.

1899 – Scale 1:2,500 – As above.

1900 – Scale 1:10,560 – The area is still farm land, there is a little more development around the village of Oldcastle (will become Bridgend) to the west of the site.

1921 – Scale 1:10,560 – The area is still farmland but Oldcastle has now become Bridgend and there has been a significant amount of expansion.

1919 – Scale 1:2,500 – Site is still farmland.

1941 – Scale 1:2500 – Site is still farmland but there has been some expansion to the Great Western Railway.

1951 – 1952 – Scale 1:10,560 – The site has become part of the Waterton section of the Royal Ordnance Factory Bridgend and sits on the northern boundary of the site. There are two large buildings on the western side of the site with an indistinct structure on the eastern side. A network of sidings has been constructed adjacent to the Great Western Railway. Presumably these were constructed to service the ROF. Construction of the Waterton section of the ROF started in early 1937 as a response to the growing Nazi threat. The section of the ROF covered by the site was not constructed until at least 1942 (see above). Production commenced at the ROF in late 1939 and continued throughout World War II. The site was mainly used as an assembly plant for the production of Detonators, Fuses, HE shells, Bombs of various types and for the manufacture of Cordite Bags. Many of the road names on the current industrial estate date back to the ROF. This would have been towards the end of the use of the ROF.

1964 – Scale 1:10,560 – This is basically the same as the 1952 map.

1964 – 1992 – Scale 1:1,250 – Due to the higher scale this map clearly shows the ROF buildings present on the site. The western boundary of the site sits on the edge of a rectangular shaped building with the side facing the site boundary being constructed in a castellation shape. There are two further large rectangular buildings along the site, one of which also has this castellation shape to its structure. These could have been constructed in this way in order to provide blast shelter for doorways or to give the walls additional strength. There are also two smaller rectangular buildings on the eastern end of the site

and the eastern boundary straddles another building which again has been constructed to this castellated design. A small embankment can be seen leading up to the two buildings at the western end of the site, along the edge of what is now Princes Way with what looks like a clear delineation between hard and soft covered areas at the top. This may explain the kerb running along the top of the present embankment (photo 4). The eastern end of the site rises at the rear of the two smaller rectangular buildings. We have been unable to identify the exact use of these buildings i.e. were they used in the manufacture and filling of ordnance or were they used as canteens, welfare buildings, laundries, workshops, etc. Due to the elevated position above the rest of the site and the proximity to the railway, it is likely that they were not used for ordnance manufacture. On the map it can also be seen that there are mounds with accesses leading to them along the southern side of the site, it is likely that these are underground magazines and munitions would have been stored in these. There are also buildings with earth embankments completely surrounding them, which are located more towards the centre of the site. It is more likely that these would have been used for the manufacture of ordnance and the mounds were put in place to shield them from blasts.

1971 – 1972 – Scale 1:2,500 - The ROF has been decommissioned and many of the existing buildings have been converted into peacetime industries. All of the ROF buildings remain at the site.

1969 – 1990 (approximately 1973/4) – Scale 1:1,250 – The ROF has been decommissioned and many of the existing buildings have been converted into peacetime industries. All of the ROF buildings remain at the site. The building on the plot to the west of the site is identified as ‘chemical works’. Other buildings are identified as ‘carpet and furniture warehouse’, ‘fibreglass factory’, wholesale electrical depot’, etc.

1973 – 1974 – Scale 1:10,560 – Many of the ROF buildings have been demolished and replaced with large industrial buildings. Three buildings remain on the site from the ROF but the building on the eastern boundary has been demolished.

Additional SIMs 1964 – 1992 – Scale 1:1,250 – This map dates from a period later than the one above (approx 1980), as the ROF has been decommissioned and the majority of the buildings have been demolished. The two large rectangular buildings at the western end of the site remain and the western most one has been joined to the building on the adjacent site. This large building is marked ‘chemical works’. The road in front of the site is now identified as Princes Way.

1982 – 1992 – Scale 1:1,250 – This map is very similar to above except that eight industrial units have been constructed to the south of the site. These are marked as ‘Bridgend Industrial Estate’ ‘factories’.

1983 – 1986 – Scale 1:10,000 – the ROF building on the most westerly side of the site has been connected to the building on the adjacent plot to form a large industrial unit which is marked as ‘works’ on the map. Another building sits in the same place as the

second ROF building and it is probable that this is the same building. The small block building on the eastern side of the site has been demolished.

1985 – 1992 – Scale 1:1,250 – This is similar to the 1982 – 1992 map above but all buildings on the site have been demolished.

1993 – Scale 1:10,000 – all buildings at the site have been demolished.

1993 – Scale 1:1,250 – This map is similar to the 1985 – 1992 map described above.

1999 – Scale 1:10,000 – No buildings are evident at the site.

2008 – Scale 1:10,000 – No buildings evident at the site.

4.1.2 Historic Environmental Data:

Discharge Consents:

The nearest consented discharge to the site is Bayer Diagnostics Mgf Ltd which discharge into the River Ewenny at NGR 292000 179100 which is south of the site. This is approximately 245m downstream from the site and therefore is unlikely to impact on site activities.

The next nearest is East Lake (Bridgend) Ltd who discharge into the Nant Pontysanau at NGR 292130 179660. This is approximately 458m from the site and is unlikely to have any impact on activities at the site.

Integrated Pollution Prevention and Control Consents:

The nearest IPPC Consent granted is for Joseph Ash and Sons Ltd, Bridgend Galvanisers on Princes Way which is approximately 45m from the site. The consent is granted for the production and processing of metals. This is unlikely to have an impact on the project.

Pollution Incidents to Controlled Waters:

The Environment Agency holds information on pollution incidents to controlled waters dating back to 1991. The nearest to the site was in 1996, the location is given as gas holder on industrial estate which was 86m from the site. The gas holder can be seen on the 1999 map to the SW of the site. This pollution incident was a spillage of heavy fuel oil. No details are given on the receiving catchment. This has potential to impact the aquifer below the site but is unlikely to have had an impact on the site.

Historical Landfill Sites:

The nearest historic landfill site is in Tremains Road at NGR 291985 179020, approximately 300m from the site. This ceased operation in 1960. The waste type is not specified.

The second nearest historic landfill is in Waunsil Avenue at NGR 291317 179479 approximately 416m from the site. This ceased operation in 1988 and the waste type is described as inert, industrial and household waste.

Neither of these landfill sites is likely to have any impact on activities at the site.

Licensed Waste Management Facilities:

Operators name: Rossini P V of 247 New Road, Porthcawl, Site Location: North Road, Grove Court Industrial Estate at NGR 292700 179400 approximately 865m from the site. Waste Management process: Vehicle dismantlers, metal recycling.

4.1.3 Hydrology:

Surface Water:

The Afon Ewenny flows approximately 600m to the south of the site but no streams or ditches were noted in the immediate vicinity of the site during the desk study or site visit. There is however surface water drainage on the site and along Princes Way and North Road. It is likely that water from this drainage discharges into a watercourse and subsequently into the River Ewenny. It is therefore important that all highway and site drainage is protected from contamination with site materials.

Water Abstractions:

The nearest water abstraction to the site is NGR 292300 178656 which is approximately 749m to the SE of the site. This is a Dwr Cymru abstraction and the well is probably collecting water from the shallow aquifer below the site. The site does not sit within a groundwater Source Protection Zone.

Groundwater Vulnerability:

Geological Classification - The site is underlain by a minor aquifer – this could be fractured or potentially fractured rocks, which do not have a high primary permeability, or other formations of variable permeability including unconsolidated deposits. Although not producing large quantities of water for abstraction, they are important for local supplies and in supplying base flows to rivers. The site does not fall within an EA Source Protection Zone.

4.1.4 Geology:

From the Envirocheck Geological Maps obtained it can be seen that there is no made (filled) ground in the vicinity of the site. The site is underlain by limestone and mudstone interbedded. There are no faults in the vicinity of the site.

The superficial geology in the area south of the site around the River Ewenny is Till, Devensian (Glacial Till) but there are no superficals at the site.

The soil encountered at the site was sandy which could be as a result of sand blown inland from the coast or due to the erosion of concrete, thus releasing the sand therein.

We have been provided with some historic borehole data pertaining to the area surrounding the site (see plan and borehole logs in Appendix I). This shows that the ground in the area around the site is made up of sand and gravel underlain by predominantly clay and limestone to varying depths. From information supplied by the BGS two boreholes have been sunk at the site but only to a depth of 1.2m so information gained from these would be very limited.

4.1.5 Flood Risk:

From Environment Agency flood risk mapping and data, there is no flood risk at the site.

4.2 Site Visit:

The eastern end of the site has been landscaped to form an undulating profile, probably to enhance the appearance of the junction between Princes Way and North Road. This section of the site has been set to grass and is well maintained. There are several semi mature sycamore trees along the southern edge of the site. The western side of the site is covered in sporadic grassland and dense scrub predominantly in the form of buddleia and bramble. Between the grassed areas there are patches of exposed concrete and gravel. There are also sections of concrete on the surface of the site ranging in size from 500mm to 1000mm.

At the western side of the site there is a kerb running along the top of the small batter adjacent to Princess Way (Photo 4). It is unclear the purpose of this but it is probable that it formed the edge of the hard area on which the buildings were constructed and an edging for a footpath around the building.

Four shallow trial pits were hand dug on the western side of the site. These were dug using a pick and shovel but all terminated at approximately 150 – 200mm depth at which point large pieces of concrete were encountered, which could not be easily removed.

The findings of the trial pitting are as follows:

- Trial Pit 1 – the ground surface was composed of gravel the average size of which was 30mm. When excavated the ground was found to be composed of small stones, small lumps of concrete, small lumps of bituminous bound aggregate and sandy earth. Concrete was struck at a depth of 130mm and we were unable to work through this with the pick. On breaking of the bituminous material to expose a fresh face, a hydrocarbon odour could be faintly detected.
- Trial Pit 2 – once again the surface of the ground was composed of gravel and sandy soil. On excavation it was found that this continued to a depth of 110mm where a large section of concrete was encountered. We were unable to remove this with hand tools and so excavation ceased. No contaminated materials or odours were noted.

- Trial Pit 3 – Once again the surface of the ground was composed of gravel and fine sandy soil. We were able to excavate to a depth of 80mm before encountering concrete. No visual signs of contamination or odours were noted.
- Trial Pit 4 – Surface of the ground composed of gravel and fine sandy soil. We were able to excavate to a depth of 90mm when we encountered a large section of concrete. We were able to find an edge to this and excavate around one end of it but were unable to remove it due to its size. No visual signs of contamination or odours were encountered.

5 Conclusions:

Under Part IIA of the Environmental Protection Act for a site to be designated as contaminated it is necessary to identify a contamination source, a receptor and a pathway between the receptor and the source. Contamination is therefore considered on a Source – Pathway – Target risk assessment basis.

5.1 Likelihood of Contamination existing at the site:

From information available it is obvious that the site has a long industrial history. It is however unclear as to its exact previous uses. As stated above it is possible that the buildings occupying the site during its period of use as a ROF were not used for the manufacture of munitions, due to their location on the boundary of the site and their proximity to the railway. They may have been used for ancillary activities such as catering, welfare, storage or workshops. This is however conjecture and no records could be found to support this. Even if these buildings were used for ancillary operations, contamination could have occurred from hydrocarbon or detergent spillage, etc. The site has not been used for at least 26 years which is sufficient time for many organic contaminants to be significantly decomposed.

WRc have produced a document for the EA titled ‘Collation of Toxicological Data and Development of Guideline Values for Explosive Substances’. In this document they set out the physiochemical properties of all known explosives including TNT. All of the explosives (where information is available) share a susceptibility to microbial degradation in soil and water with a half life ranging from hours to several months. The resulting compounds produced depend on the material used. Information on this process for many explosives used is limited due to the semi classified nature of the explosives and the lack of published research in this field. As the site has not been used for the production of munitions for over sixty years it is likely that if there were explosive substances within the soil they would have been degraded to their constituents.

The 1980 map clearly shows the site being used as a ‘chemical factory’ but no information could be obtained on the exact nature of this business. It would therefore be reasonable to assume that some sort of ground contamination could be present but it could also be the case that the previous industries at the site were well operated with impermeable bases and adequate drainage to ensure that no contamination occurred.

Munitions manufacture at the site predates the use of depleted uranium so exposure to radiation should not be an issue.

5.2 Targets/Receptors:

The key receptors which could potentially be impacted by contamination are:

- The aquifer below the site and subsequently abstractions from the aquifer.
- Construction personnel during the construction of the new facility. Activities such as the installation of deep drainage would pose the greatest risk.
- Personnel working at the new facility. These would be subject to the most long term exposure.

5.3 Pathways:

Aquifer – there is an abstraction point some 749m to the SE of the site, which is operated by Dwr Cymru. If contaminants in soil were to be mobilised due to the works, there is a possibility that they could enter the aquifer and the surrounding population could be exposed. It is not clear at what depth the aquifer sits and from borehole information available it can be seen that the surrounding ground is composed of bands of limestone interspersed with clay and overlain by sand, earth and gravel. Without further geological review it is not possible to identify the source of water entering the aquifer and hence assess a possible pathway for contamination. There is no merit in carrying out further modelling of groundwater pathways and linkages at the present time as it is not known if there are any contaminants within the soil below the site and if so, what their nature or characteristics could be.

Direct contact with contaminated soil during construction – i.e. ingestion, inhalation, absorption. Once again in order to assess risks associated with this it would be necessary to identify contamination. Mitigation against this could be through the use of good working practice and suitable PPE.

Vapours through soil – Need to identify potential for this following further site investigation.

Risks to workers at the facility from long term exposure to contamination – this could be better assessed following further site investigation. This risk will be controlled to a great extent due to the impermeable base for new development. Under most circumstances this would isolate workers from contaminants in the soil.

5.4 Recommendations:

Bayliss Recovery are currently negotiating a lease for the site with the condition that planning permission is granted for the development. It is therefore essential that Bayliss Recovery has a thorough understanding of any historic contamination present at the site, so as to be able to accurately calculate likely development costs and risks.

We therefore recommend that prior to the signing of a lease, trial pits are dug and samples taken for chemical analysis in order to determine the presence or absence of contaminants within the sites soil and identify requirements for remediation works, if required. This process would also allow the identification of buried foundations and structures which may need to be removed as part of the development and could impact on costs for the project. Locations for trial pits and depths would need to be agreed on site following removal of vegetation and a survey of the site in order to identify buried services. Samples retrieved should be tested for metals, hydrocarbons and organics.

Further investigation and remediation works may be required dependant on the outcome of this. This will also allow the developer to be able to adequately risk assess works at the site.





Historical Aerial Photography - Slice A










Photo 12: Trial Pit, Manhole and Kerb Location.



Flood Map - Slice A




