This was a routine unannounced site inspection undertaken by Environment Officers Andrew Sowerby and Paul Challender. Mark Williams accompanied us throughout the inspection.

Whilst waiting in the office at the start of the visit a copy of Mark Williams most up to date continuing competency certificate was observed on the wall. This certificate showed a 2018 expiry date.

No issues were observed on site during the site inspection. The vast majority of the waste metal on site was observed to be stored within skips as opposed to in open bays. No WEEE is currently being stored on site.

Overall the site was observed to be very tidy and organised.

The sites Environment Management System was briefly discussed and I mentioned that following a brief review of it there was some information that might need including. As Mark Williams said that he was in the process of finishing an update of it, it was agreed that the update would be sent to me and then I could provide any suggestions/comments.
