Key issues of the decision

Receipt of application

The Application was accepted as duly made on **5th March 2019**. This means we considered it was in the correct form and contained sufficient information for us to begin our determination, but not that it necessarily contained all the information we would need to complete that determination.

Operator

We are satisfied that the applicant (now the operator) is the person who will have control over the operation of the facility after the grant of the permit transfer. The decision was taken in accordance with EPR RGN 1 Understanding the meaning of operator.

Environment management system

There is no known reason to consider that the operator will not have the management systems to enable it to comply with the permit conditions. The decision was taken in accordance with RGN 5 on Operator Competence.

Relevant convictions

Our Enforcement Database has been checked to ensure that all relevant convictions have been declared for 2 Sisters Poultry Limited.

No relevant convictions were found.

Financial provision

There is no known reason to consider that the operator will not be financially able to comply with the permit conditions. The decision was taken in accordance with RGN 5 on Operator Competence.

OPRA

In line with Section 20 of NRW Charging Scheme 2018-19, where the transfer application relates to the whole of a permit and demonstrates that the management of the transferor and the transferee are substantially the same, the sum of £1999 will be charged.

Therefore OPRA is not required for this application.
