4. Details of our assessment

On 6th January 2022 Natural Resources Wales (NRW) received a Schedule 6 Notification from Kennametal informing them that the emission limit value (ELV) for particulate emissions from emission point A6 had been breached.

The measured value for particulate emissions from emission point A6 during routine monitoring on 22nd November 2021 was 26.8+/-1.2mg/m³. The ELV is 25mg/m³. Taking into account the uncertainty values, this result is within 10% of the ELV and so NRW will not issue a non-compliance at this stage. However, NRW may change this decision should further information become available.

The new scrubber system for this emission point has been ordered and installation is planned for April. This should reduce emissions from A6, allowing Kennametal to comply with the ELV for this emission point.

Kennametal should make every effort to ensure that this installation date is met.
