### Introductory note

#### This introductory note does not form a part of the notice

The following notice gives notice of the variation of an environmental permit.

This permit variation is to convert the current standard rule permit (SR2008\_No25) into a bespoke (Tier 3) permit. The permitted activity remains the same; a clinical waste transfer station with treatment activities. However, permitted treatment now includes treatment of specified waste for recovery, as well as disposal. The activity codes required to permit the treatment for recovery activities (i.e. R3 and R5) were not covered within SR2008\_No25, hence this variation to a Tier 3 Bespoke Permit was necessary. The conditions relating to the new activity have been issued as a separate document.

The schedules specify the changes made to the original permit.
