Site visit conducted by David Ellar and Michael Edwards, accompanied around site by the site operator.

During the visit it was noted that there had been improvements to the general management of the site with waste well organised and segregated. Improvements to the sites infrastructure were also noted with the construction of a new road from the weighbridge to the treatment shed to reduce rutting of the hardstanding.

Storage of wood.

During the previous visit it was highlighted that some waste wood was not being stored on the impermeable pad, as required under the permit. This visit found improvements had been carried out and the amount of waste wood on site had been reduced. All waste wood was now stored on an impermeable pad.

Pooling water (drainage).

Surface water pooling on the hardstanding area was still an issue during the visit. Improvements are still required to be undertaken in this area. (see image above for pooling water). It is important that the drainage systems in place are maintained to ensure that no waste water can discharge into nearby watercourses. This is a breach of condition 2.1.2 of your permit and have been **scored a category 3 breach** as a result. After the inspection David Ellar contacted Simon Morris by telephone and Simon explained that further infrastructure works including more concreting of the site were planned.
