A routine visit took place on Friday 15th September, 2017. The regulating Officer Julie Hughes was accompanied by Steve Rymill throughout the visit.

Weather on the day was intermittent rain and sunshine.

Tipping at the quarry was taking place during the visit with 3 lorries arriving and tipping. Areas where previous tipping had taken place were inspected for material suitability. Very small amounts of plastic and metal were seen but these are handpicked on a regular basis by the site operative and placed in the quarantine skip located next to the site office.

The WAMITAB certificate of the TCM is up to date.

I observed the wheel wash being used by a departing lorry. The wheel wash in combination with the road sweeper, which was also in use, ensured that the highway was kept clean.

No permit breaches recorded during this site visit.
