4. Details of our assessment

NRW officer Phil Harper visited Humphreys Waste Recycling Ltd, Refail Newydd, Caergeiliog, Holyhead, Anglesey, LL65 3DX on the 7th January 2022.

Weather conditions were overcast but dry. The site was operational at the time of the visit.

The inspection was accompanied throughout by Cai Humphreys, technically competent manager.

C1 Staff Competency/ Training

Records indicate that Cai Humphreys is covered by the necessary WAMITAB qualification until September 2023. No issues regarding competence observed.

C3 Materials Acceptance

Waste returns for the site have been reviewed against the permit. No issues regarding waste acceptance have been highlighted.

No issues regarding waste acceptance were observed on site.

C4 Storage Handling and Segregation

Waste on site was clearly segregated from sorted waste fractions. All waste was stored within appropriate bays and within buildings. No issues were observed.

F1 Odour

No odours noted outside of the site boundary or outside the transfer building.

F3Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.

Site diary was reviewed. All required information present. No issues observed.
