General:

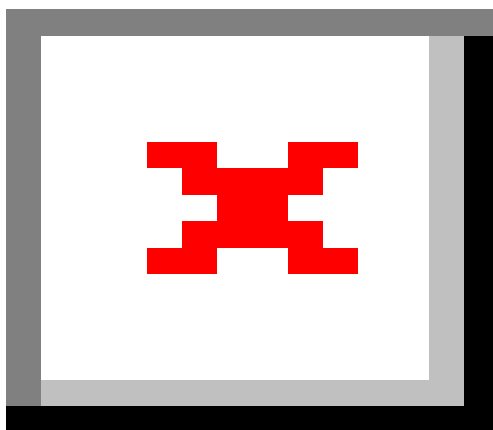
The site was quiet busy with several lorries coming into and leaving the site during the inspection. The site was well managed and good segregation of wastes was observed.

Permit Breaches:

The impermeable surface is still worn and cracked in several places and this has been recorded as a **Category 3 non-compliance**. This issue has been highlighted and recorded as a breach of permit on each visit. It was encouraging to see works had now started to repair the worse effected area. An on-going repair, maintenance and inspection plan needs to be put in place to ensure no further breaches are recorded.

Actions from last visit:

Impermeable surface - several of the last Compliance Assessment Reports (CAR) have identified damage to the impermeable surface. Works has now started to repair the concrete.

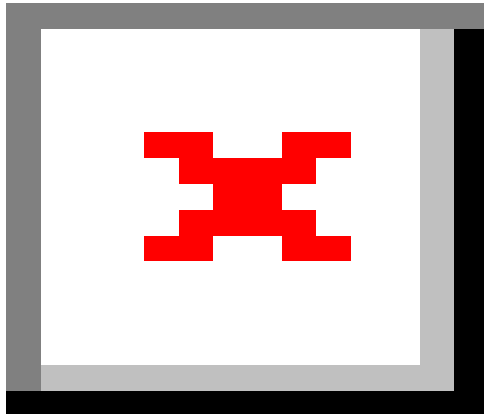


Unpermitted wastes:

The unpermitted waste types (Gas cylinders, and general waste skips) identified on our previous visit had been removed.

Storage of drained liquids in ELV are:

The storage of the liquid wastes has been improved. They are now stored in individually marked containers on a bunded pallet.
