A routine site inspection took place on the 31st August, 2016. The site was closed at the time of the visit due to the new opening hours which means the site is now closed to the public on Wednesdays and Thursdays.

There were no issues highlighted on the site, all waste was contained in skips as per permit requirement.

The site was clean and tidy.

A desk top review of waste returns for 2015 and 2016 was carried out. This has highlighted that the site is wrongly coding the acceptance of waste bicycles by using waste code 16 01 06 which is not a permitted waste in Schedule 1 of your permit. The miss coding of waste has resulted in a **CAT 4 breach of Schedule 1 table 2.1**
