A routine site visit took place on 15th August, 2017. The Regulating Officer was accompanied on the inspection by Sean Benyon.

The site was open during the visit with members of the public present during part of the inspection.

Members of the public are no longer asked to open black bin bags containing mixed waste. The purpose was to maximise recycling however following verbal abuse of staff this had stopped.

The Operating times of the site has been reduced. The site is now only open 5 days out of seven with Gwalchmai CA site being open on the days that Penhesgyn is closed.

Public / businesses using site – checks are carried out on regular users of the site which could be business use i.e. builders using cars or small trailers to bring in paint pots, builders rubble, garden waste etc. If it is suspected that someone coming onto site is a business they should be discouraged with information passed to the Local Authority and Natural Resources Wales to follow up and provide advice and guidance regarding duty of care if appropriate.

The site environmental management system (EMS) was available for inspection. The EMS required updating as the previous site manager's contact details were still included as an emergency contact. An electronic copy of the EMS should be sent to NRW.

Advice & Guidance

Please ensure that battery box lid is secure during wet weather to stop the ingress of water. Batteries should not be sitting in water at any time.
