### **Environmental Monitoring Review (January - December 2018)**

We have reviewed the above report submitted with regard to permit condition 4.2.2. Please see our comments below.

#### **Other Environmental Reporting**

The volume of leachate disposed to off-site increased from 9,139 m<sup>3</sup>/yr in 2017 to 17,963 m<sup>3</sup>/yr in 2018.

Landfill gas consumption at the site has increased from a total of 5,232,397 m<sup>3</sup>/yr in 2017 to 5,900,453 m<sup>3</sup>/yr in 2018.

#### **Perimeter Gas Monitoring**

Perimeter gas permit limit exceedances have been scored in previous CARs.

#### **Surface Emissions Survey**

The GPS route on drawing FID Surveys Compilation 2018 indicates Cell 1 was not surveyed.

A Surface Emission Monitoring Procedure written by the operator was received by NRW on 29/03/2019 and is currently being reviewed.

#### **Point Source Emissions to Air**

Table S3.2 Point source emissions to air - emission limits and monitoring requirements requires that NO<sub>x</sub>, CO, Total VOCs are sampled annually at the landfill gas engines.

No engine emissions monitoring results have been received by NRW for 2018.

**Action 1:** Confirm whether this sampling was undertaken during 2018, and provide a copy of the monitoring report to NRW, by 30/04/2019.

#### **Trace Gas Sampling**

Table S3.8 Landfill gas - other monitoring requirements requires that trace gases are sampled on an annual basis at a representative sample location.

**Action 2:** Confirm whether this sampling was undertaken during 2018, and provide a copy of the monitoring report to NRW, by 30/04/2019.

#### **Leachate**

Leachate level permit limit exceedances have been scored in previous CARs.

### **Groundwater**

Groundwater chemistry was within Permit limits.

### **Surface Water**

Surface water permit limit exceedances have been scored in previous CARs.

### **Amenity**

Table S3.12 Particulate matter in ambient air requires that deposited dust is sampled on a quarterly basis on the NW boundary and the SE boundary. This monitoring data has not been provided to NRW for 2018.

**Action 3:** Confirm whether this sampling was undertaken during 2018, and provide a copy of the monitoring results to NRW, by 30/04/2019.

### **Reporting**

Condition 4.2.2 requires that a report or reports on the performance of the activities over the previous year shall be submitted to NRW by 31 January each year. At the operator's request, an extension to this deadline was agreed by NRW, to 31/03/2018. The report was received on 29/03/2018, therefore before the agreed deadline.

However, as outlined in the previous sections above, the report did not include the following information:

- engine emissions monitoring results for 2018;
- trace gas sampling results for 2018; and
- particulate matter monitoring results for 2018

**This breach has been scored a CCS Category 4 breach of Permit.**
