Amend all reference to drawing reference number s.2003/WD/001 dated 25/03/2003 and replace with drawing reference number CWMWD/01 dated November 2008.

Condition 1.2.2

The quantities of wastes accepted shall not exceed those listed in section 1.1 of the working plan. Whilst complying with the maximum quantities specified for each type of waste, the total quantity of waste accepted at the site per year shall not exceed 30,000 tonnes per annum.
