The purpose of the visit was to assess the compliance of Wern Tarw Recycling Ltd with the environmental permit EPR/EB3430RT.

We were met on site by Leighton Shillibier, the Technically Competent Manager (TCM) for the site. The current WAMITAB certification for the site had expired but a continuing competency course was in the process of being booked.

### **Waste Storage**

Mr. Shillibier gave us a brief overview of the operations on site during a walk around the permitted area. The site appeared relatively organized with all waste being stored in accordance with their environmental permit. 90% of the site was serviced by an impermeable pad with the remaining 10% being covered in hard standing.

There was a large gap between the yard and the site next door, belonging to Paul Cox Skips. Mr. Shillibier explained that he takes his crusher (under a mobile permit from the Local Authority) and crushes on that site.

Advice and Guidance given to recommend a gate or similar is installed to prevent unwanted access outside of operational hours.

### **Environmental Permit and Environment Management System**

Following a tour of the yard I requested to see copies of the environmental permit and environment management system. These were available electronically. Advice and Guidance was given to ensure that copies of both these documents are available at all times on site and staff have access to up to date copies.
