The purpose of the inspection was to assess the current compliance of FCC Wales Services (UK) Limited with their Environmental Permit EPR/FB3539DV.

We were met on site by Darren Hemming, the Technically Competent Manager (TCM) for the site and a tour of the site was undertaken.

Waste Acceptance and Storage

At the time of the visit the site appeared well organised and tidy. There had been some changes to the layout of the storage units on site which had made a vast improvement. Wastes were being stored in accordance with the Environmental permit and no rogue wastes were visible. All storage units and skips were structurally intact and easily identifiable to members of the public.

The doors on the storage sheds at the entrance of the site had been replaced by caged fronts, ensuring a higher level of security.





It is very pleasing to see that general housekeeping on site is now of a good standard and all of the actions highlighted during the previous inspections are still being complied with.

Environment Management System and Environmental Permit

Copies of the Environment Management System and Environmental Permit are readily available on site.

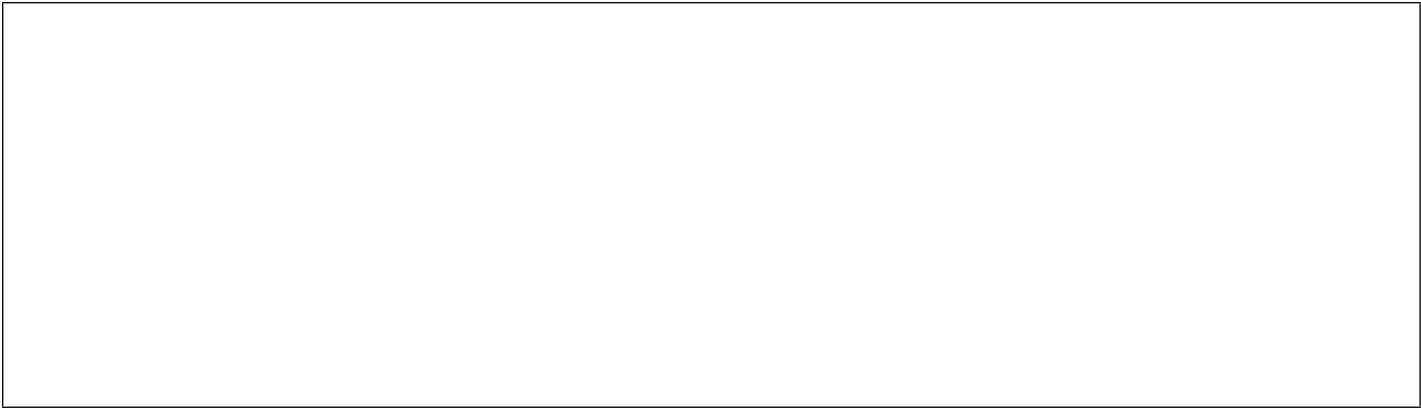
The WAMITAB qualification held by Darren Hemming, the Technically Competent Manager for the site is up to date.

Black Bag Treatment

A proposal has been submitted to Natural Resources Wales to undertake treatment of black bag waste at the site.

Members of the public will be asked to open selected general waste bags they bring onto site in order to ascertain whether or not any recyclables can be retrieved. An updated Environment Management System has already been provided to reflect the proposed changes and the site have been advised that a detailed risk assessment of the planned activity also needs to be completed before this goes ahead. It is likely that this will begin sometime in January 2018.
