PERMIT

WHEREAS on the 12 September 1997 the Environment Agency granted you a waste management licence relating to the keeping of controlled waste on land, licence number SWW168L.

NOW the Environment Agency **HEREBY GIVES NOTICE** that:

The conditions of the licence are hereby modified as follows:

Condition G1 shall now read 'The Licence Holder shall by 22 February 1998 enter into a bond agreement or any other suitable arrangement agreed with the Agency to make financial provision adequate to discharge the obligations arising from this Licence.'

The following conditions are hereby added:

Condition G2 'No waste shall be accepted, treated or kept at the Site after the 22 February 1998 if the bond or other arrangement referred to in condition G1 above has not been concluded by the Licence Holder and the Agency.'

Condition G3 'The financial provision accepted under condition G1 above shall be maintained by the Licence Holder from the date of the acceptance by the Agency throughout the subsistence of the Licence and the Licence Holder shall produce evidence of such provision whenever required by the Agency.'

This modification shall take effect at 00.00h on 24 December 1997
