No site inspection had been done at the site for some time and as the sites new regulating officer I took the time to re-familiarise myself with the site.

Overall the site was observed to be relatively tidy and well organised.

The operator is proposing to erect a shed on site within which waste will be stored and sorted. Currently trying to get planning permission for this shed.

It was highlighted on site that there was a small amount of green waste n site. Green waste is not listed within your permitted waste types in the permit and as a result should not be accepted onto site. It was mentioned that this had been discussed with the sites previous regulating officer and that the operator was of the understanding the issue had been resolved. It was explained that to accept green waste at the site the permit would need to be varied to include the additional waste types.
