4. Details of our assessment

Form S1, Emissions to Sewer, 1st October to 31st December 2021, was received on 18th January 2022.

The average daily discharge was 35.17m³ over 63 days, making a total discharge of 2216m³. The total discharge and daily discharge were more than in Q3 2021, despite the site operating for slightly fewer days.
