A site inspection of Derwens RRF (Refuse Recycling Facility) was undertaken by David Morgan on 24 November 2016.

It was noted during the inspection that all the RDF bales were stored inside the building, with approximately 3 days' worth of bales stored at any one time. There was a container being loaded with RDF during the inspection. There was no back log of RDF bales. Waste segregation was good, and the site was generally tidy.

Hard plastics and builders waste bags were baled and stored outside in under cover bays, as per permit conditions. You are currently building more bays outside.

Actions from previous CAR form:

- **Ensure all wastes are stored in accordance with your permit conditions** – Complete. All RDF was stored inside the building, and all other waste were under cover.
- **Ensure shut down of conveyers etc are written into the management system & fire risk assessment for the site and are undertaken** – please confirm.
- **Ascertain the volume of the sump and ensure the sump and drains are working effectively. Consider adding checks to your inspection schedule** – please confirm.
- **Explore other options of securing the site due to unwanted visitors** – please confirm.
- **Consider adding sandbags to damn doorways of RRF building to your fire mitigation plan for containment of fire water** – please confirm.
- **Fire water exiting the building likely to enter drains/lagoon. Positioning of sandbags to be explored** – please confirm.
- **Please forward a copy of your Final Fire Prevention and Mitigation Plan once it is completed.** – Currently NRW only hold a DRAFT version.
- **Please provide drainage plans for the site** – awaiting copies.

At our meeting on 01 December 2016 I will ask for updates on these action points.
