Waste Return Review for Permit No:LB3593HD

On CAR Form issued 03/03/2016 we scored you for the non-compliance with condition 4.2.2 of your permit and you were required to submit the missing waste returns for quarter 4 2014, and quarters 1, 2, 3, & 4 2015 to waste.returns@cyfoethnaturiolcymru.gov.uk no later than the 15th April 2016. Unfortunately Natural Resources Wales have not received these missing waste returns.

Also on the same CAR form dated 30/03/2016 you were also requested to put a system in place to prevent this breach of condition 4.2.2 from occurring again. It is apparent that the requested system has also not been successfully implemented as we are yet to receive any waste returns from you since. As a direct result of the lack of an effective system being implemented to prevent the breach of condition 4.2.2 from continuing to occur, a CCS score 4 has been applied against the management condition 1.1.1. of your permit. Also as a result of both breaches of permit occasion a site warning has also been issued on this form.

As you have also continued to fail to submit the waste returns for quarter 4 2014, quarters 1, 2, 3, & 4 2015 and then subsequently for quarters 1, 2, 3, & 4 2016 and quarters 1, & 2 2017, a CCS score 4 has also been applied against condition 4.2.2 of your permit.

Action Required

- You are required to submit the missing waste returns for quarter 4 2014, quarters 1, 2, 3, & 4 2015, quarters 1, 2, 3, & 4 2016 and quarters 1 & 2 2017 to waste.returns@cyfoethnaturiolcymru.gov.uk no later than Wednesday 13th September 2017.
- You are required to implement and follow a management system no later than the 13th September 2017 to prevent the breach of condition 4.2.2 from occurring again.
