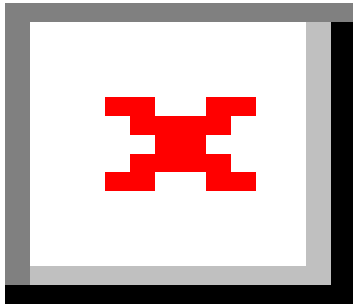

This was an unannounced inspection by the new regulating officer for the site Steven White, TCM Matthew Davison accompanied officer throughout the inspection.

There was little waste stored on site, some small piles of stones and rubble but mainly one pile of road planings - Matthew Davison explained that this was the majority of the waste type that they accept and deal with on site.

There were a couple of small fuel/oil spills observed around the equipment stored on site, these were minor and were not of concern. Spill kits are available on site in case of larger spills, during the inspection a leak of what was thought to be brake fluid coming from one of the machines on site. This was brought to the attention to one of the engineers who began looking into it immediately, the machine was parked on an area which was drained to the site oil interceptor.

During the inspection waste returns were briefly discussed, Matthew Davison said that he needed to submit Q1 (2017) returns and that he would be doing that soon. During a review of past waste returns the following issues were found:

- There were no waste returns submitted for all of 2016 – can you submit these as soon as possible (if these have already been submitted can you forward me the confirmation you received of this)
- In a review of the 2015 returns it was noted that you have included the waste code 17-09-04 (mixed construction and demolition waste) on the returns in Q1, Q2, Q3. This waste code is not on the list of wastes that can be accepted at your site; you would need to check that the waste is correctly coded, if so you will need to vary your permit to include this waste
- The non-submission of waste returns for 2016 has been scored as a breach of permit condition 4.2.2 ('Within one month of the end of each quarter, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.')

The above breach has been scored as a C4 CCS breach against the permit.
