Generally, the site was seen to be kept tidy and well organised. One surface water drain near the road sweepings bay was seen to be heavily blocked with mud and debris. Please ensure that this drain is cleaned and remains free of blockages. A CCS Category 4 score has been recorded against this non compliance.

A breach in the rear road sweepings bay had been repaired.

Please keep me up to date with the Councils progress with regards to the proposed new MRF site in Mochdre.
