A site visit took place on the 18th May, 2017. Present were Fiona McKilligan of Bryson, Vincent Thomas Site Manager, Mark Cassidy of Conwy Council and Julie Hughes Regulating Officer.

The site is in the process of changing with the building being split to accommodate the offices and a recycling shop. Any salvage items must be intercepted for the shop before they are placed within a skip.

Several skips will be placed within the Bron y Nant site next door. A new gantry has been built within the Bryson site which will allow the public access to deposit their waste into these skips. The acceptance and removal of this waste will be dealt with by Bron y Nant. A permit variation will not be required as the waste will be deposited and removed under the Bron y Nant permit.

An area immediately to the left of the building as you enter the site is operated under an S2 exemption as this area is not within the permitted boundary of the site.

Several personnel are being trained to attain their WAMITAB qualification.

The site working plan/EMS will require updating with the new site operations. A copy of the updated working plan is to be sent to NRW by 30th June, 2017.

No breaches of permit conditions were recorded during this visit.
