This was a routine unannounced site inspection visit by the Environment Officer Paul Challender. At the time of the visit the weather was warm, still and bright. Mr G. Jones a site attendant from FCC Environment was present on site and assisted with the inspection when required.

At the time of the inspection site was open and accepting waste from the public.

A selection of paperwork was reviewed in the site office. The Visitors Book, Site Diary and check sheets were all readily available to review and where necessary; completed in a suitable manner. These documents were well utilised; including references made to the current serviceable state of site plant which, was undergoing maintenance works at the time of the inspection.



Three site attendants were actively assisting the public with advice and guidance on the disposal of wastes. The site was well labelled and signed to assist disposal and to advise the public of unauthorised wastes and activities. During the inspection one attendant actively stopped the unauthorised removal of a bicycle from the site advising the potential offenders of the reasons why it could not be removed. The occurrence was well handled and the site operative commented that it was not an unusual occurrence for people to attempt to remove bicycles.



On the whole the site was in good order however, there was a quantity of litter behind the containers. In general there was significantly less litter around the site compared to the last inspection however, the current levels of litter behind the containers should be addressed to ensure that it does not become a fugitive emission.

The condition of the rubble containers on site is much improved and the disposal chutes appear to make the depositing of waste easier which in turn has led to less waste escaping the containers and fouling the yard. Thank you for conducting these

improvement works.
