The purpose of the inspection was to assess compliance of Hydrock Contracting Limited with their Environment Permit, reference EPR/HB3197TM

Michael Roper gave an introduction to the operations carried out on site. The site has not been operational for approximately a year. This is due to the electricity feed into the unit having been stolen. Following several rounds of monitoring the current Benzene discharge rate is 35 kg/day. Due to the target level being 50 kg/day the treatment process has not been re-started. Hydrock Contracting Limited have submitted these results to Atkins who are consultants to the landowners St Modwen and are awaiting further instruction.

The compressor unit was viewed. This was securely locked, but not operational due to the reasons highlighted above.

Michael Roper confirmed that the named staff had completed their relevant continued competence certificates and copies would be forwarded on. These have been received and meet the requirements of condition 1.1.4.

An annual waste return has been submitted. The permit EPR/HB3197TM only requires quarterly returns to be submitted.

Nil returns are required to be submitted until the permit is surrendered when no treatment activities are taking place on site.
