3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Forms A1, Emissions to Air, W1, Emissions to Water and S1, Emissions to Sewer for 1st October to 31st December 2021, were received on 19th January 2022.

All parameters were within their respective emission limit values.

The reports are accepted.

EnerSys have not been able to sample emissions to water from W1 since 10th November 2021 due to an intermittent electrical fault. Natural Resources Wales (NRW) were not informed of this breach of permit condition 3.5.1. EnerSys should have informed NRW, following the procedures given in permit conditions 4.3.1 and 4.3.2, as soon as they became aware of the potential breach of a permit condition. A Cat 3 non-compliance has been issued for this breach.

Remedial actions required are given in the table above.

CAR_NRW0038844, issued on 21st October 2021, concerning a failure to notify NRW about an incident that occurred under a previous management team, detailed a number of corrective/remedial actions to ensure that there was no recurrence of a similar problem. It would appear that these actions have either not been fully completed, did not cover the full scope of permit conditions 4.3.1 and 4.3.2 or were not as effective as they should have been. EnerSys have therefore been issued with two Cat 4 non-compliances.

Remedial actions, very similar to those detailed in CAR_NRW0038844, are given in the table above.

NRW will require documentary evidence that all the actions have been completed. This should be received by the due date for the relevant action.
