4. Details of our assessment

This is the first visit to the site since 2019. There have been a number of communications between L Warrick and R Soper during this time. Mainly to do with the possible variation of

the permit to include other EWC codes.

Mr Soper was unable to attend the site inspection. E Davies accompanied L Warrick. The site has seen very little activity in recent months with just one delivery of asbestos roofing in the previous 12 months. This consignment note was forwarded to me on the 7th of January.

The asbestos compound was clean and tidy. The drains were free from blockages and all signage regarding the hazards the waste presents were clearly visible. The compound was secure.

Spillage kits and double bagging facilities along with an asbestos vacuum cleaner are held within the compound. The filters are changed as required. There is a filter within the drainage system which is also checked and changed in accordance with the management system.

Please ensure all consignment notes and premise registration if needed are up to date and available. This information should be kept for waste moving onto the site as well as a register of returns for waste moved from the site. Please ensure consignee returns are completed to the producer and you keep a register of returns from the onward movement of waste from your site.
