Forms W1, Emissions to Water and S1, Emissions to Sewer for 1st October to 31st December 2021 were received on 19th January 2022.

All emissions to water were within their respective emission limit values (ELV).

The reported emissions to sewer are above the ELV for aluminium. This is an average value and any individual high values will have been dealt with using the Schedule 5 Notification and CAR systems.
