We discussed changes to the standard Rules set 2012No14 which now requires the production of a written Fire Prevention and Mitigation Plan. As the drainage requirements remain the same, Julie Young intends to apply for a bespoke permit that will allow a discharge from the oil interceptor. The existing permit will be varied to a bespoke permit. As a bespoke permit has been applied for, Failure to apply for a bespoke permit by 25 September 2017 will result in reissuing a Regulation 36 Notice.

Vehicles that had been depolluted could not be inspected as they were in the waste pile.

The site was tidy and the waste well sorted. The concrete that could be inspected was in good condition.
