I write regarding the enforcement notice dated 23 August 2016 served on you by Natural Resources Wales (NRW) under Regulation 36 of the Environmental Permitting Regulations 2010. The deadline on the notice expired on the 16 February 2017.

Unfortunately we have not had confirmation of outcome from the consultation into changes to the Standard Rules Permit 2012No14, which you currently operate under.

If there are no changes to the Standard Rules 2012No14, it will be our intention to reissue the Regulation 36 notice with an appropriate timescale to enable you to comply.

We will be in contact with you regarding this matter as soon as we are clear on the outcomes of the consultation process.
