This was a routine unannounced site inspection carried out by the new regulating officer Paul Challender. During the inspection the weather was blustery with intermittent rain. The operator, Rosalind Jones accompanied the officer during the inspection.

The site was quiet at time of inspection with no waste acceptance or processing activity ongoing. There were approximately 15 ELVs stored on site. All ELVs were stored appropriately on the impermeable concrete pad. Batteries were stored appropriately in a suitable container. Site was tidy and well organised with all waste metal streams segregated and stored appropriately.

No non compliances were noted with regards to waste acceptance criteria. During the inspection no amenity issues relating to dust, litter, noise, odour or pests were observed. Site surfaces were in good condition and appeared to be free from any signs of spillages or contamination and the drainage to the interceptor was free from obstruction.

No records or documentation were inspected during this visit. A copy of the valid Certificate of Technical Competence is held by the regulating officer. Technically Competent Management (TCM) cover was discussed and the relevant qualification and required attendance level for the site is in place.
