The following notice gives notice of the variation of an environmental permit.

This is a regulator initiated variation of a tier 3 landfill permit to:

- incorporate the closure report approved by Natural Resources Wales;
- reduce the waste input for disposal to zero;
- include a condition requiring the operator to maintain a closure and aftercare management plan.

This permit variation reflects the status of the site as being in definite closure.

The schedules specify the changes made to the original permit.

5.9.1 The operator shall maintain a closure and aftercare management plan.

5.10 Operating Techniques

5.10.1 (a) The activities shall, subject to the conditions of this permit, be operated using the techniques and in the manner described in the documentation specified in Table 5.10a, unless otherwise agreed in writing by Natural Resources Wales.

5.10.1 (b) If notified by Natural Resources Wales that the activities are giving rise to pollution, the operator shall submit to Natural Resources Wales for approval within the period specified, a revision of any plan or other documentation (“plan”) specified in Table 5.10a or otherwise required under this permit which identifies and minimises the risks of pollution relevant to that plan, and shall implement the approved revised plan in place of the original from the date of approval, unless otherwise agreed in writing by Natural Resources Wales.
