A routine site inspection was undertaken on Friday 12th June 2015.

The following observations were made;

At the time of the inspection the yard was busy and although large volumes of material were stored on site the site appeared to be very well organised. Wastes were clearly segregated and there were no signs of spillages/poor storage practices. An inspection of the raised area of the site was undertaken. This part of the site is outside of the permitted area and whereas there were a number of vehicle parts stored in this location these parts (HGV axels, cars etc.) are not considered waste.

The site surface has been well maintained and showed no signs of significant damage.

There was no WEEE items mixed with the main scrap pile and scrap metal waste has been removed from the embankment (unmade ground).

The inspection chamber for the discharge to soakaway was accessible for inspection. The surface water in this chamber was free from oils and grease and is therefore compliant with the permit condition. This suggests the drainage system with interceptor is well maintained and is functioning as intended.

Condition 1.1.4 of the permit was breached (Category 4 - No Impact) (Ref: C1)

A non-compliance with no environmental impact was recorded as the WAMITAB had recently expired. Please ensure the necessary continuing competence qualifications are undertaken at the nearest convenience.
