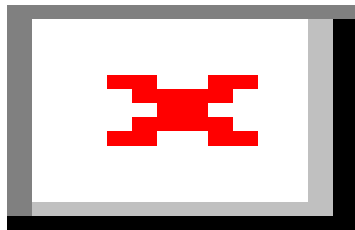

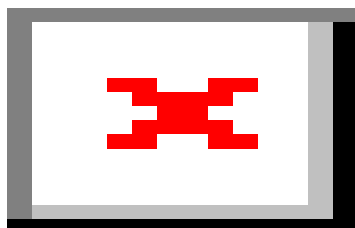

This was a routine unannounced site inspection of the Anglesey County Council Gwalchmai site. During the inspection the weather was still and dry after a period of rain. The inspection was carried out by Environment Officer (EO) Paul Challender. EO Challender was accompanied by Gwynedd for the duration of the inspection.

At the time of the inspection the civic amenity was closed to the public and maintenance work was being carried out. All waste receptacles and their contents were able to be inspected and all appeared to be correct.



The remainder of the site is comprised of the council's waste transfer operation. During the inspection waste was being accepted from household collections. Although no sorting operations were taking place; Gwynedd explained the processes and also the inputs and outputs to the inspecting officer. All wastes were segregated and stored appropriately with no evidence of wastes escaping site or access to waste or the site by unauthorised persons.



In the weighbridge office the Site Diary was inspected along with a selection of checklists and other documents and all appeared to be correct. Good use of checklists was evident with the recording of recent damage and the status of the remediation recorded.
