4. Details of our assessment

Ffion Quan and Jeremy Goddard undertook an unaccompanied site inspection of Cwm Quarries. It was unclear prior to the visit whether or not this permit for the permanent deposit of waste on land was currently operational.

A site inspection was undertaken to establish the current status of the permit. Whilst on site, it was seen that material had been deposited at the vicinity of Quarry 1. See photograph below.



No waste had been deposited at Quarry 2.



You contacted Natural Resources Wales regarding pre-surrendering your permit, but no further correspondence has been received. Please note that an accurate and comprehensive record of the activities in accordance with the waste recovery plan would be required for any future surrender application. The annual subsistence fee remains payable until the permit is surrendered.
