4. Details of our assessment

A routine site inspection was undertaken on Tuesday 18th January 2022.

Present on site at the time of the inspection were David Morgan (Natural Resources Wales) and Andy Thomas (GMS Ltd).

Site Infrastructure

The inspection began with an assessment made of the site boundary. During the previous inspection (31st March 2021), it was noted that a portion of the concrete wall was damaged and had fallen down. As a result, site security was compromised and waste could potentially have escaped if being moved in/out of this area.

On 18th January 2022, it was clear that this wall had been fixed. In the far left corner of the site (upon entering) it was noted that some waste materials had escaped the site boundary. It would appear that during the loading/unloading process, some waste had fallen behind the boundary wall and off site.

It was agreed that this would be rectified as soon as possible. This has been recorded as an **ACTION** for you to complete.

Since the previous inspection, it is noted that the site surface has been maintained and concreting works have taken place. However, the site surface in the left corner of the site (upon entering from Siloh Road) is damaged. There did not appear to be any environmental impact. There was no spills/leakages/pools of contaminants.

A discussion was held on site and it appears plans are already in place to resurface this area of the yard.

Vehicle Depollution

It is likely that in a future inspection, officers would like to undertake an audit of the vehicle depollution process. This will be arranged prior to the next inspection.

The vehicle depollution shed appeared to be in good order. There were no spillages of oil as had been identified in the previous inspection.

WAMITAB

The Technical Competent Manager (TCM) for the site is Mark Tymkiv. WAMITAB records indicate that qualifications for Metal Recycling and End-of-Life Vehicle Depollution were achieved on 10th August 2021 and 14th September 2021 respectively.

No non-compliances with the Environmental Permit were recorded during the inspection.
