4. Details of our assessment

NRW officer Phil Harper visited Hefin Thomas Agri Contractors Ltd, Plot 7, Mona Industrial Park at 10:15am on the 11th January 2022.

Weather conditions were dry and sunny. The site was operational at the time of the visit.

The inspection was accompanied throughout by Maldwyn Griffith. This was an announced inspection, which focussed on the site operation.

Servicing of Vehicles

During the site inspection it was noted that the company carries out vehicle servicing at the premises. Please note that if a site produces more than 500 kg of hazardous waste annually then the site is required to register as a hazardous waste producer. Hazardous waste includes oils and batteries. C1 Staff Competency/ Training

Records indicate that Simon Thomas is covered by the necessary WAMITAB qualification until September 2022. No issues regarding competence observed.

C3 Materials Acceptance

Waste returns for the site have been reviewed against the permit. No issues regarding waste acceptance have been highlighted.

No issues regarding waste acceptance were observed on site.

C4 Storage Handling and Segregation

Waste on site was clearly segregated from sorted waste fractions. All waste was stored within appropriate containers and bays. No issues were observed.

F1 Odour

No odours noted outside of the site boundary.

F3Dust/fibres/particulates and litter

No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
