4. Details of our assessment

NRW officer Phil Harper visited Veolia ES (UK) Limited, Ecopark Mon, Plot 8A, Mona Industrial Estate, Gwalchmai, Isle of Anglesey, LL65 4RJ on the 7th January 2022 at 10:35. Penny Hughes, business manager accompanied the site inspection.

Weather conditions were dry and overcast.

Although the site benefits from an SR2008 no.7 permit, very little waste activity takes place on the site which is mainly used to store skips and bins and to park vehicles.

C4 Storage, handling labelling and segregation

At the time of the visit waste UPVC frames and mattresses were being stored at the site. These wastes were stored appropriately. No issues were noted regarding waste storage.

D1 Site Security

No issues noted regarding site security.

F1 Odour

No odours on site or outside of the site boundary.

F3Dust/fibres/particulates and litter

Ground conditions were damp at the time of the inspection. No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.
