**ENVIRONMENTAL PROTECTION ACT 1990 - SECTION 37  
MODIFICATION OF WASTE MANAGEMENT LICENCE NUMBER 31**

On the 24th July 1998 the Agency wrote to you because your waste management licence allows you to receive wastes which were not special prior to 1st September 1996, but which may now be classed as Special under the Special Waste Regulations 1996.
