This compliance assessment report has been completed following the pre-planned site inspection undertaken on 14th June 2017 as part of the on-going regulatory compliance of the Tradebe Installation permits NP3233XX and GP3298FY at Bridgend.

During the inspection the waste facility permit, GP3298FY was also inspected. The operational management of the waste facility has cross over with the installation permit. The full details of the inspection have been recorded under CAR form NRW0031849,

This CAR form has been produced specifically for the waste facility permit file and sorted under the sites NRW file.

Areas of the permit related to waste acceptance and monitoring (F1-F8) and site management operations (E1-22) were considered (assessment is under CAR NRW0031849)

The GP3298FY permit is currently in a very old format and permit variation advice has been sought on consolidation of the permits and update to EPR regulation standard. Once a response is received from internal NRW colleagues an update will be forwarded to Tradebe. Car NRW0031849 includes pre-application advice on variation and consolidation.
