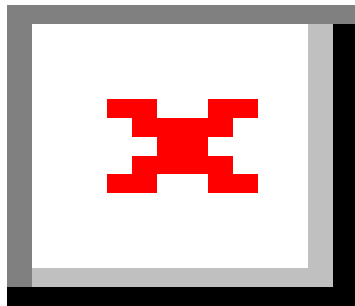

This was an unannounced inspection following the renovation of the site to the new two-tier layout, Regulating Officer Steven White was accompanied by Danielle Richards during the inspection.

The new layout of the site has been in place since mid April and seems to be working well, the site operatives and the public have both said that they prefer it to the old one-tier layout.

There were no issues observed on site, all the correct wastes were stored within the appropriate receptacles, there was no litter observed on site and the surface water drains were clear.

There were a number of drums observed by the office, see photo below, these had recently been moved from the Chemsafe and were due to be picked up by the contractor later that day. All other chemicals were stored safely within the locked Chemsafe on site.

There had recently been some damage caused to the site by vandalism where paint had been thrown around, and some other damage caused to the site - this was cleaned up promptly after the event and there had been no re-occurrences.
