A review of the submitted 2014 and 2015 waste returns for permit number EPR-BP3291EB has been completed and the following issues have been found.

### **c3) General management - materials acceptance**

In the waste returns for 2014 and 2015 LoW (list of waste) code 20 01 99 (municipal waste/separately collected fractions/other fractions not otherwise specified) has been used to report the acceptance of waste types such as books, Tetrapak packaging and oil filters. Similarly, LoW code 20 03 99 (municipal wastes not otherwise specified) has been used for waste types such as carpets and mattresses.

These list of waste codes are not currently permitted by your environmental permit. For future reference, 20 01 01 (paper and cardboard) should be used for books, 15 01 05 (composite packaging) should be used for Tetrapak packaging, 16 01 07\* (oil filters) for oil filters, 20 01 11 (textiles) for carpets and 20 03 07 (bulky waste) for mattresses. These list of waste codes are all permitted by your environmental permit.

### **g4) Monitoring and records, maintenance and reporting - reporting & notifications. Permit condition 6.2.2. CCS score 4.**

Waste returns have not been received for quarter 1 (January to March) and quarter 2 (April to June) 2015. This is a breach of permit condition 6.2.2 and receives a CCS score of 4. Please submit the missing returns by 30th April 2016.

Can I also remind you that your returns for quarter 1 (January to March) 2016 are due to be submitted by 30th April 2016.
